The Community Weatherization Coalition (CWC) helps Alachua County renters and homeowners reduce their monthly utility bills and save resources by providing free supplies and instruction to perform "Do it Yourself" (DIY) Home Energy Tune-ups. Energy Tune-Ups may save \$200-\$300 annually on your household's utility bills.

Performing your own CWC Energy Tune-up includes an initial phone or email consultation with CWC staff prior to the inspection of your home. During the inspection, you will follow our checklist to examine major appliances and install the energy and water-saving items provided in your kit. Our staff is available to help review your utility bill remotely and suggest further ways to lower your energy and water expenses after we review your completed checklist.

My name or signature below indicate that all of the statements on the previous page are true and correct to the best of my knowledge and belief.

I, as owner or tenant of the above residence, have read and understand the above and hereby grant permission for representatives of Rebuilding Together North Central Florida DBA the Community Weatherization Coalition; hereafter "the CWC" to collect data regarding my energy and water use, home repairs needed, if noted, and to provide suggestions to improve my energy and water consumption.

I will conduct the DIY energy tune-up to the best of my ability and follow the provided checklist and diagrams to guide me before performing any unfamiliar task. I further understand that CWC representatives WILL NOT BE PRESENT and ARE NOT RESPONSIBLE for anything broken or damaged while I follow the checklist and install the suggested energy and water-saving measures. I agree to ONLY perform the tasks I am comfortable with and in the means of my physical abilities.

I hereby agree to release the CWC, its personal representatives, agents, volunteers, successors and assigns, from any and all past, present and future claims, demands, obligations, causes of action for damages of any kind, known or unknown, in any way related to the above actions or based upon any work I perform at my own residence with the CWC DIY KIT, whether founded by contract, common law, breach of warranty and/or workmanship.

I understand that should problems arise with the work I performed using the CWC DIY Kit Supplies, or should further repairs be required, the CWC is not required to make any such repairs.
